FOR CLARKSON FM GRAVES INFO HCGINLES CITE JIG 22486 PD ACTION PROPOSED IN YOUR ROGER JIG SIX EIGHT FIVE EIGHT THREE APPEARS TO ME TO BE SOMEWHAT MORE DRASTIC THAN REQUIRED PD DESPITE MY VERY CRITICAL COMMENTS ONE SHOULD NOT OVERLOOK THE FACT THAT SUCH A REPORT CONTAINS MUCH VALUABLE AND INTERESTING INFORMATION PD I AM NOT AWARE OF A BETTER DISCUSSION OF WEATHER OVER THE MARSHALL ISLANDS THAT APPEARS IN THE FIRST TWO CHAPTERS PD WITHDRAWING THE REPORT FROM CIRCULATION WITHOUT REPLACING IT WITH A REPORT MORE ACCEPTABLE TO YOU WOULD DEPRIVE OTHER HEADQUARTERS OF MATERIAL FOR WHICH THEY MAY WELL HAVE A REAL REQUIREMENT PD IN VIEW OF THE VALUE OF MATERIAL CONTAINED IN THE REPORT I WOULD PREFER THAT CONSIDERATION BE GIVEN TO PREPARATION OF A TASK FORCE REPORT AT THE END OF CASTLE WHICH WOULD INCLUDE MATERIAL GIVEN BY THIS REPORT AND WOULD SERVE AS A BASIS FOR RECALLING THIS REPORT AT THE TIME PD I WILL REGRET HAVING A COPY OF THIS REPORT IN THE HANDS OF THE JOINT CONGRESSIONAL COMMITTEE PD I HOPE THAT DDA WILL FIND IT POSSIBLE TO DENY THEIR REQUEST HOWEVER I DO NOT THINK THAT THIS SHOULD BE A WORK OF YOURS PD AS AN ALTERNATIVE SUGGESTION TO YOURS ONE A CRITIQUE BY OTHER COMPETENT METEOROLOGISTS TO BE SENT TO RECIPIENTS OF THE REPORT SHOULD BE MOST USEFUL PD CAPTAIN WYWARD WHO WAS ALSO A METEOROLOGIST ON OPERATION IVY MIGHT BE WILLING TO MAKE SUCH A CRITIQUE IF HE WERE ASKED BY YOUR HEADQUARTERS PD
